# Northern Hills Area CASA <u>Director's Report</u>

May 7, 2024 – June 10, 2024

#### Goals:

- o Enhance the work environment through the emphasis of teamwork.
- Promote retention of CASA volunteers through continuous support and educational training.
- Raise public awareness of NHCASA, child abuse prevention, and the unique role our volunteers play in the child welfare system.
- Maintain fiscal responsibility by increasing the amount of income received.

## Foster a positive culture of the work environment.

- Weekly team meetings are held, which include staffing of all cases and discussions regarding fundraisers, volunteer engagement, and grant applications.
- Monthly one-on-one SOS (Source of Support) meetings between the ED and staff members: Progress with 2024 personal/professional goals. Importance of engaging in self-care activities.
- An exit interview is scheduled with Chelsie Perschbacher for June 13.

## Strengthen the quality and professionalism of advocacy efforts.

- > The staff discuss cases on a weekly basis to ensure best practice advocacy efforts.
- We currently have 25 CASA volunteers, along with NHCASA staff, advocating for 48 children on 29 cases. CASA volunteers, Marcia Barnes, Lisa Merkel, and Linda Stambaugh are assigned to two cases each. Thirteen CASAs have been appointed to cases in 2024, with six of them being graduates of our February-March training session. We are lucky to have a larger pool of available advocates vs. the number of abused/neglected children currently in care.
- We have served 66 children thus far in 2024. Since the May 9, 2024, board meeting, we have received one new case in Butte County. Total year-end numbers for 2023 were 85 and 75 in 2022.
- We are fortunate to be able to fulfill our vision by having CASAs assigned to every child who is in DSS custody. We currently have two children waiting for a CASA to be their voice. A Butte County case was reopened and involves a sixteen-year-old boy whose needs are too significant for the mother to handle. Due to the lack of placements, DSS has been staying with the young man and his mother at a hotel in Spearfish since April 24, 2024, at a cost of \$150 per night. The adolescent attends Black Hills Special Services during the day. The new case involves a 2-year-old girl who was involved in a car accident with her mother who was under the influence of methamphetamines. The family has prior involvement with Child Protective Services, due to sexual abuse by the father on the teenage girl. Their parental rights were terminated with regard to her. She is now an adult. The father is a registered sex offender. The Butte County State's Attorney's office and DSS may be seeking termination of parental rights, as ASFA (Adoption and Safe Families Act) is applicable in this case. The child was left alone after the accident in the middle of the night in 38-degree weather, wearing only a diaper. She was sitting on the mother's lap during the accident and spent hours unattended, bruised, muddy, and cold. After an extensive search, she was located in an abandoned warehouse 1/4 mile from the accident scene.
- CASA Michelle Clark willingly accepted an appointment regarding the seventeen-year-old Ziebach County male who is placed at Falls Academy in Sioux Falls. He will age out of the system on July 28, 2024, and plans to go live with his father in Michigan. His mother is deceased, and his father had his parental rights terminated due to physical abuse on this young

- man. CASA Michelle visited the teenager over Memorial Day weekend and is advocating for his independent living needs, as a means to prepare him for the reality of adulthood.
- CASA Virginia Mollman has been a volunteer since April 2021. She has advocated for four children on two different cases. After taking some time off from being a CASA volunteer, she completed the necessary continuing education in order to resume to advocacy. CASA Virginia has an extensive medical background. She took on a short-term case involving a sixteen-year-old female who was a victim of sexual abuse by her father. Both parents denied any wrongdoing and didn't want to work toward reunification. They wanted her to be placed with relatives in other states, just like what happened with her biological brother, who also made allegations of sexual abuse by the father. The young lady wanted to remain in the foster home, where she had built a positive relationship with her foster parents. She was enrolled in public school for the first time in her life and enjoyed it immensely. CASA Virginia's contacts and visits with the teenager proved valuable at the hearing, as the young lady was adamant she didn't want to return home. Everyone felt strongly about trying to avoid this adolescent being put on the stand for testimony, in front of her alleged abusers. After diligent efforts by CASA Virginia and the child's attorney, the case closed with a guardianship with the foster parents. Judge Fitzgerald praised the efforts of CASA Virginia.
- We have attended 93 abuse and neglect hearings since January 1, 2024, plus a federal sentencing in Pennington County, several criminal hearings regarding parents, and Drug Court proceedings. We also participate in Adoption Conference Calls.
- We hosted our annual Child Watch Tour on May 7. The NHCASA team, along with six volunteers and one board member participated. Five facilities which serve children and families were featured: Compass Point, Children's Advocacy Center, New Alternatives, Arise Youth Center, and the Juvenile Services Center. A special thank you to Vern Bills, of New York Life Insurance, as he was our lunch sponsor.
- ➤ We hosted a Cup O' CASA event on May 29. Two new volunteers were present and shared their experiences of being a new CASA.
- ➤ Please plan on attending the CASA Family Picnic on Thursday, June 20, at the Spearfish City Park, from 5:30 7:30 p.m. Bring a dish to pass.
- The Court Improvement Program, along with the Center for the Prevention of Child Maltreatment, hosts virtual Lunch & Learn events dealing with child advocacy. The invitation to participate is emailed to all CASA volunteers and board members. Previous sessions can be viewed at <a href="https://sdcpcm.com/our-work/cip/">https://sdcpcm.com/our-work/cip/</a>. May's virtual learning opportunity was facilitated by a former NHCASA volunteer. She talked about child trafficking in South Dakota. Two advocates, two board members, and NHCASA staff participated. The next session is scheduled for June 26, at 11:00 a.m. MT. It will focus on the activities of the 2024 SD Legislative Session. These are free sessions, but you must register in advance in order to receive the Zoom link to participate:

- Refer to the updated NHCASA Calendar of Events for the virtual educational sessions regarding "Understanding ACEs (Adverse Childhood Experiences), "Enough Abuse," and other learning opportunities. Several CASA volunteers are taking advantage of these learning opportunities for their 12 continuing education hours which are required by the National CASA Association.
- Anna and I hosted a quarterly meeting with the Family Services Specialist Supervisors from Sturgis and Spearfish, plus the DSS Regional Manager. This collaboration is key to the continued success of our mission.
- Anna and I continue to meet monthly with the Children's Worker, DSS Supervisor, and Attorney Karen Hunt to discuss long-term cases. We also participate in weekly calls with CASA volunteers and DSS for case updates.

- > Team meetings are held on a regular basis between CASA, children's attorneys, and DSS, in an effort to provide best-practice advocacy efforts regarding the best interest of children.
- ➤ Other learning opportunities Chelsie participated in were entitled: "A Strong Pitch: Earning Media for Fundraisers and Events" and "20+ Simple Fixes to Unlock the Power of the Paddle Raiser."

### Increase public awareness of the mission of NHCASA.

- We hosted a vendor booth at the Gravel Grinders bike race registration day on June 7 at the Spearfish Pavilion. Over 450 people were present. I shared information about NHCASA and our upcoming summer fundraising races. One person expressed interest in becoming a CASA volunteer. Others were interested in running the half marathon and participating in the BHS6.
- > CASA Volunteer Luke May was the guest speaker at the Learn About CASA event. Three people attended and are interested in taking the Fall training class. One potential volunteer read the flyer about the event when she was voting in Sturgis, and another saw the information on a grocery store bulletin board in Belle Fourche.
- Due to personnel issues, along with five people who expressed an initial interest in taking the summer training session, yet because of their busy summer schedules, opted to continue with the Fall class, we will not be hosting the June new volunteer training. We anticipate another very large class in September/October.
- > Chelsie promoted our organization by participating in a check presentation with Sturgis Strikers Bowling Alley.
- ➤ We will be participating in the Canyon Acoustics Series, sponsored by Spread the Tunes, on Wednesday, July 3, from 6:00 8:00 p.m., with the proceeds from the 50/50 ticket sales going to NHCASA. We need volunteers to assist with this event.
- We may have a float entry for the Spearfish Independence Day Parade. We are looking into having volunteers donate bags of candy for the activity.
- Anna participated in a video shoot and check presentation with Roughlock Auto. Please share the video on social media.
- NHCASA utilizes our website, social media, area Chamber of Commerce newsletters, church bulletins, flyers hung in various businesses throughout our coverage area, Visit Spearfish, and the Black Hills Pioneer newspaper to promote the NHCASA mission, continuing education training events, and fundraisers. Chelsie is also posting information about NHCASA on Instagram.
- ➤ Event sponsorships are continuously being procured. We had a committee meeting for the Black Hills Super 6 Mountain Bike Race, which involved three community members, a board member, CASA Marcia Barnes (who is an avid bike rider, and her family consistently participates in the BHS6), and the NHCASA team. Watch for the KEVN TV ad regarding the upcoming races.
- > The May NHCASA "Advocate" newsletter was mailed out to over 350 people and emailed, through Mailchimp, to over 200 recipients.
- ➤ In conjunction with Child Abuse Prevention Month, Queen City Salon had two April dates, in which owner/operator Lauren Cermak, donated the proceeds of free haircuts to NHCASA. \$219 was given to our program.
- > The Spearfish Canyon Half Marathon/5K promotional flyer was included in the June Spearfish Chamber of Commerce newsletter, which included 670 recipients.
- We partner with other local organizations to promote our program. I am a board member of the Lawrence County Coalition and attend monthly meetings. We are also involved with the Sturgis ABC (Action for the Betterment of the Community) and the Northern Hills Interagency groups.

▶ I, along with NHCASA Treasurer Jessie Dufner, presented our grant proposal to the SD CASA Commission. We were allocated \$23,000, as compared to \$18,400 in 2023. It should be noted funding may decrease in 2025 with the addition of two new CASA programs.

We received grant funding in the amount of \$26,000 from the SD Court Improvement Program, an increase of \$1,000 from 2023. This money is used to reimburse staff salaries.

➤ Black Hills State University donated 50 cinch bags to NHCASA.

The Spearfish Canyon Half Marathon/5K registration is open, with 171 people registered thus far (compared to 194 at the same time in 2023). Payments are sent to us via Innovative Timing. Registrations are open for the Black Hills Super 6, as well. We are giving away a donated Strider bike to one lucky winner who registers for the BHS6 by June 14.
