Northern Hills Area CASA Director's Report

July 9, 2024 – August 12, 2024

Goals:

- Enhance the work environment through the emphasis of teamwork.
- Promote retention of CASA volunteers through continuous support and educational training.
- Raise public awareness of NHCASA, child abuse prevention, and the unique role our volunteers play in the child welfare system.
- o Maintain fiscal responsibility by increasing the amount of income received.

Foster a positive culture of the work environment.

- Weekly team meetings are held, which include staffing of all cases and discussions regarding fundraisers, volunteer engagement, and grant applications.
- Monthly one-on-one SOS (Source of Support) meetings between the ED and staff members: Progress with 2024 personal/professional goals. Importance of engaging in self-care activities.

Strengthen the quality and professionalism of advocacy efforts.

- > The staff discuss cases on a weekly basis to ensure best practice advocacy efforts.
- We currently have 23 CASA volunteers, along with NHCASA staff, advocating for 44 children through 26 cases. CASA volunteers, Marcia Barnes and Lisa Merkel, are assigned to two cases each. Fourteen CASAs have been appointed to cases in 2024, with six of them being graduates of our February-March training session. We are lucky to have a larger pool of available advocates vs. the number of abused/neglected children currently in care.
- We have served 68 children thus far in 2024. The total year-end numbers for 2023 were 85 and 75 in 2022.
- We are fortunate to be able to fulfill our vision by having CASAs assigned to every child who is in DSS custody. We currently have two children waiting for a CASA to be their voice.
- Since the July 11, 2024, board meeting, we have received two new cases. One involves a 15-year-old male who was in the previous custody of DSS from 2015 2021. After years of advocating for the child's needs, his CASA volunteer adopted him. However, due to the adolescent's escalated behaviors which resulted in an unsafe home environment, the adoptive father requested to have his parental rights terminated, as he is unable to meet the boy's needs. The youth is currently in the legal custody of both DSS and the Department of Corrections. With past scenarios like this, the abuse and neglect case was simply re-opened. Consequently, DSS has stated this is no longer the policy/procedure. Thus, a new abuse and neglect petition was filed against the adoptive father. A Meade County case was filed during the Sturgis Rally. Mom has a history of involvement with Child Protective Services in another state. She was apparently moving to South Dakota with her boyfriend. She was arrested for possession and ingestion of drugs. The 7-year-old boy is placed in a temporary foster home.
- CASA volunteers, Shawna & Patrick Goldhammer, were appointed to the Butte County case involving a sixteen-year-old boy with significant developmental delays. Sadly, this young man's placement in Nebraska was disrupted, so he is again residing in a hotel in Spearfish, under the direct 24/7 supervision of DSS. He will be placed in a fictive kinship home prior to the start of the school year and will continue with his education through Black Hills Special Services.

- ▶ Julia O'Neil-King has been actively involved in the NHCASA program since October 2020. She has been the voice for 6 children through 3 cases. She has played an instrumental role in effective advocacy for the 3 young girls on her current case. The children have experienced multiple placements, some of which were in Sioux Falls. Thankfully, she conducted monthly visits with the children, at each location, over the past two years. CASA Julia has encouraged the girls to participate in culturally appropriate activities and will be taking them to an upcoming Pow Wow. The mother's parental rights were terminated in April 2023. Additional trauma occurred with the murder of their father and half-brother on the Pine Ridge Indian Reservation. CASA Julia, along with a DSS worker, transported the oldest child to the funeral. DSS, attorneys, and Judge Fitzgerald have praised CASA Julia for her efforts, as she continues to go above and beyond. She has been featured as a guest speaker at "Learn About CASA" events and multiple new volunteer training sessions. She also spearheaded endeavors to present information about our program to various civic organizations within the community. CASA Julia has received the Optima Excellence and Excellence in Court Reporting awards.
- CASA Kattie Bland was sworn in on October 13, 2022. She was appointed to her first case in January 2023. After 18 months of advocating for a girl, who is now six years old, the case ended with an adoption by the maternal grandparents. Throughout her time as a CASA, Kattie, a teacher, had another child and switched school districts. The adoptive resource intends to keep CASA Kattie involved in the child's life.
- We have attended 132 abuse and neglect hearings since January 1, 2024, plus a federal sentencing in Pennington County, several criminal hearings regarding parents, juvenile delinquency hearings, and Drug Court proceedings. We also participate in Adoption Conference Calls.
- ➤ We hosted a Cup O'CASA event on July 31. Two board members and four CASA volunteers were present for coffee and conversation.
- The Court Improvement Program, along with the Center for the Prevention of Child Maltreatment, hosts virtual Lunch & Learn events dealing with child advocacy. The invitation to participate is emailed to all CASA volunteers and board members. Previously recorded sessions can be viewed at https://sdcpcm.com/our-work/cip/. The next session is scheduled for August 28, at 11:00 a.m. MT. The topic will be "The Role of a Qualified ICWA (Indian Child Welfare Act) Expert." - Refer to the updated NHCASA Calendar of Events for the virtual educational sessions regarding "Understanding ACEs (Adverse Childhood Experiences), "Enough Abuse," and other learning opportunities. Several CASA volunteers are taking advantage of these learning opportunities for their 12 continuing education hours which are required by the National CASA Association.
- Another free virtual training entitled, "Understanding and Responding to Problematic Sexualized Behaviors in Children," will be held on August 15, 22, and 29. Refer to the board packet for more information.
- Anna and I continue to meet monthly with the Children's Worker, DSS Supervisor, and Attorney Karen Hunt to discuss long-term cases. Unfortunately, the Sturgis and Spearfish DSS offices were forced to take on additional Rapid City cases, which has resulted in increased caseloads. For example, one Family Services Specialist (FSS) had a case transferred to him which involves 11 children in 6 different placements. A veteran FSS Supervisor switched jobs. We are grateful for the hiring of a current worker from within that office.

- Anna and I facilitate weekly calls with CASA volunteers, children's attorneys, state's attorneys, and DSS for case updates. We are also prioritizing contact with advocates who aren't currently assigned to cases, in an attempt to keep them actively engaged. This is a prime retention method.
- ➤ In-person team meetings are held on a regular basis, between CASA, children's attorneys, and DSS, in an effort to provide best-practice advocacy regarding the best interest of children.

Increase public awareness of the mission of NHCASA.

- I presented a grant proposal request to the Meade County Commissioners on July 23. Even though our largest caseloads come from Meade County, we haven't received funding from them since 2010, despite the annual requests. Over the last few years, the percentage of children we serve in Meade County, as compared to our overall totals, has been consistently in the 44-47% range. We have advocated for 68 children in 2024 thus far, with 32 of them from Meade County. With regard to county funding, grants continue to be fulfilled from 6 of the 8 counties we serve. It appears NHCASA was awarded varying amounts from Meade County from 2005-2010, totaling \$2,500 \$11,440, for each of those years. I explained the annual average cost of one CASA volunteer to an organization is \$4,341. In the first seven months of 2024, there have been 15 advocates appointed to cases in Meade County, which equates to a financial burden to our program of \$65,115. We requested a grant for \$17,364 which would offset the expenditures for four volunteers serving children in their community. I urged them to make abused and neglected children in Meade County a priority. It should be noted we also haven't received money from the City of Sturgis since 2020. However, we are grateful for the support of the Sturgis Rally Charities (annual est. funding of \$5,720).
- We utilized social media, websites of the Chamber of Commerce in Spearfish, Sturgis, Lead, Deadwood, and Belle Fourche, Chamber of Commerce e-news, Visit Spearfish, our website, and the ITSYOURRACE app to promote the half marathon/5K and the BHS6 mountain bike race. We also distributed flyers in nearly every community from Newell to Rapid City. KOTA Territory featured advertisements about the races on television. The Black Hills Pioneer donated ad space, as well.
- The Spearfish Canyon Half Marathon-5K had 455 registered participants. Each person received information about our program during packet pick-up. We were thrilled to have eight CASA volunteers and four board members help with the event. Refer to the attached revenue-expense spreadsheet for additional details.
- The Days of '76 VIP Bar was a huge success, raising \$4,560.30, breaking a new record for tips. The revenue was up \$1,100 from the 2023 event. We utilized NHCASA koozies and cowbells as incentives for \$5 tips, "selling" over 150 items. We talked to many people about the CASA mission and ways to volunteer.
- We hosted a Pre-Registration Party at Sawyer Brewing Company on August 9, 2024. Unfortunately, most of the patrons were Rally-related.
- The inaugural BOD onboarding session occurred on July 9. Present were the 3 new board members, along with their mentors. Board Development Chairperson Natalie Owens and I presented information regarding BOD responsibilities, committees, bylaws, policies, procedures, program-related activities, and various other NHCASA items. Each mentee received their board manual.
- > Due to the staff shortage, I participated in a website refresher training with Life Light Creative.
- NHCASA Monthly Spotlights are highlighted on our website at www.nhcasa.org, featured in our newsletters, and recognized on our NHCASA Volunteers private page on Facebook. We partner with other local organizations to promote our program. I am a board member of the Lawrence County Coalition and attend monthly meetings. We are also involved with the Sturgis ABC (Action for the Betterment of the Community). We provide the Zoom link and facilitate the Northern Hills Interagency quarterly meetings. The last meeting was held on July 9, with Anna as the facilitator.
